The report has been submitted to the US Army Corp of Engineers. If it is determined to be impacted, it will require remediation by purchasing up to 2 wetland credits.
- Moving forward with the sale of land to Lippert, a purchase agreement has been sent to Lippert's attorney for review & edits.

A motion was made to approve the sale of 9 acres at the price of \$36,000 to Lippert. Jason Holt made a motion to approve. Hal Wiley seconded the motion.
