- MillEx is hosting an Open House Event the second week of July. The Development Authority and Chamber are supporting this event and the community is invited.
- There was a bid received for the truck staging area at Polar Park that came in over budget. This bid will be rejected and bidding will be opened back up.
- Cottage Innovation Kitchen bidding is open and will close out June 22, 2023.
- The Sirco Industrial project has been canceled. There is a buyback clause and the process of buying back the land is in the works.
- Homeland Security will be coming next week for a meeting about the Emergency Communication System. Kimberly Hobbs with SGRC will be attending the meeting to tie in with other counties.
- The McSwain property will be closed Tuesday of next week.

• Jason Dunn proposed that the Development Authority move forward with negotiations and due diligence with J Floyd Investments to purchase property to potentially build a building to lease to Advanced Aluminum. The board consented to entering negotiations with J. Floyd Investments.
