Jason Dunn, Executive Director, provided the following updates:

- The engineering process with Peachtree Business Park continues.
- · Meeting today with West Fraser to accept the check for \$250k in connection with the Workforce Development/College & Career Academy.
- · Mana Nutrition coordination with teams from Fitzgerald Water, Light and Bond and Electric Cities of Georgia regarding solar project.
- The truck staging area with Polar Beverages has been delayed due to the rain.
- Advanced Aluminum is meeting with a couple of contractors on the building project.
- Eagle Railcar aims to create over 75 jobs in a three-year period. They appreciated the incentives provided but are focusing on the job tax credit incentives from the state. Just waiting for their announcement.
- The kitchen project is being advertised again and has been placed on the procurement registry.
- The UGA Propel program welcomed students into Fitzgerald last week.
- The leadership program kicked off last week and went well.
- P25 Communications project study should be received today and will be forwarded to Kathy Young, Mike Dinnerman and Motorola for a quote so it can be returned by March 22nd.

Taylor noted how well the communication flow has been from Senator Ossoff's office with Fitzgerald and Ben Hill County. All present agreed that this has been the best communication from a Senator office in some time.

Tinley questioned the jobs that would be available for Eagle Railcar. Dunn shared the positions that they are looking for and the starting wages.
